




#### Organization of Electricity and Natural Gas Internal Markets



#### Organization of Natural Gas and Electricity Markets




### Organization of Natural Gas Market Unbundling






### Organization of Electricity Market Unbundling

#### Framework for managing the Security of gas Supply

#### **Protected Customers**

- All households
- SMEs+ essential social services=20%
- District heating installations (without fuel switching possibilities)

#### **Infrastructure Standard**

- Guaranteed supply to all customers in the event of a disruption of the single largest infrastructure
- **Bidirectional capacity** to be established in all cross border interconnections for physical reverse flows of gas

#### **Supply Standard**

- Guaranteed supply to Protected Customers
  - under sever conditions:
- 7 day temperature peak (once in 20 years) or
- 30 days exceptionally high demand (once in 20 years) or
- 30 days without the largest infrastructure working (average winter conditions)

#### Safeguard Security of Supply

#### Priorities at the regional level

Security of Gas Supply is a shared responsibility of Member States establishing "Union emergency" / "regional emergency" mechanisms

- -Joint preventive and emergency action plans
- -Common Security of Supply Measures
  - Development of Southern Gas Corridor;
  - Diversified and adequate LNG supply;
  - •interconnection of the Baltic region
  - the Mediterranean Energy Ring;
  - •adequate north-south gas interconnections within central and south-east Europe






